

**RESOLUTION NO. 26-6**

**A RESOLUTION PURSUANT TO §7-6-4006 OF THE MONTANA CODE  
ANNOTATED, AUTHORIZING AMENDMENT OF FINAL BUDGET FOR  
FY 2024/2025 TO ACCOUNT FOR UNANTICIPATED REVENUE AND EXPENSE.**

**WHEREAS** Prairie County wishes to amend the budget for Fiscal Year 2024-2025 to provide increased appropriations in certain funds

**AND WHEREAS**, such amendment of the final budget will result in an overall increase in appropriation authority within the funds identified herein,

**AND WHEREAS**, the provisions of §7-6-4006 MCA require public hearing upon any budget amendment resulting in an overall increase in appropriation authority,

**NOW, THEREFORE, BE IT RESOLVED** by the Prairie County Board of Commissioners as follows:

1. The appropriations for the Final Budget for Fiscal Year 2024-2025 shall be increased in the following amounts:

- Appropriations of **\$161,900.00** in fund 2110 will be increased for unanticipated expenses and revenue due to a loan of \$139,692.00 for the purchase of rotary loader and ARPA funds transferred in the amount of \$43,401.31.

- Appropriation increase of **\$1063.70** in fund 2190 for unanticipated expenses in paying a deductible in Property Casualty Liability Fund. An operating transfer from funds 2899- Oil and Gas Prod Fund to 2190 will occur.


- Appropriations increase of **\$159.57** for unanticipated expenses and revenue accrued from interest in fund 2390- Drug Forfeiture.

**BE IT FURTHER RESOLVED THAT** a public hearing shall be held on the above proposed amendment to the Final Budget for Fiscal Year 2024-2025 on the 3<sup>rd</sup> day of September 2025, at 1:30 pm in the Prairie County Court House. The Clerk & Recorder shall cause notice of such hearing to be published in the Terry Tribune, in accordance with §7-1-2121 MCA, at least 2 times with at least 6 days separating each publication.




