Prairie County Board of Commissioners Todd Devlin, Christine Keltner and Dennis Teske met in regular session at 9:00 a.m. In attendance Administrative Assistant Harry McNall.

9:00 a.m. Pledge of Allegiance, public comment.

Commissioner Devlin wanted to make public that he sent an apology to Shane Eaton for his comments during the April 23rd meeting. Commissioner Keltner made an apology as well today for her comments. (Devlin's Written Apology Appendix A)

Sheriff Lewis has a public comment about purchasing a container for the department. He has found three containers and would like to know if we would like to purchase all three?

Road Supervisor Todd Henry joined the meeting to talk about roads. The road department is down one person and will be posting the position in the newspaper.

Todd Tibbets had a concern about the limit stopping emergency services across this bridge, he believes we need to push back on the state bridge reports. Sheriff Lewis is concerned about emergency services crossing these bridges with low load limits. Could we put up a one-way traffic sign, for those bridges?


